TODAY, THE FOUNDATION HAS EXPANDED ITS SUPPORT FOR THE COLLEGE AND ITS STUDENTS WITH RESOURCES FOR SCHOLARSHIPS, FACILITIES, WORKFORCE DEVELOPMENT, AND INNOVATIVE PROGRAMS.
